### I. Call to Order

## II. Approval of Minutes

## III. Treasurer's Report

As of 4/30 we have, in Banco Popular, \$119,637.84, in Checking, \$71,555.78 in savings, plus CD's of \$164,000.88 for total funds in Banco Popular of \$355,194.50. In We Florida Financial, we have \$82,283.74 in Savings and CD's of \$20,529.63 for total funds in WFF of \$102,813.37. We have \$458,007.87 in total association funds. We earned \$62.05 extra income, unexpected income of \$108.33 and \$0.00 in reimbursement income. We have accounts receivables over 2.4K which includes \$0.00 in legal fees, \$0.00 in unit repairs and violations of about 1.2K. The total amount for possible collection is about 1.1K.

#### IV. Architectural Committee Report

There was no report submitted by the Architectural committee for this month, but arch requests have been submitted for review.

### **V. Fines Committee Report**

No hearings were scheduled for this month. There will be hearings in August 2019.

### VI. Old Business

- a. **Entrance Project Update** We discussed getting a permit expediter to speed up the process.
- b. **Violations** Nelly submitted some violations for roof cleaning & follow ups...
- c. **LED** program will take 4 to 6 months to complete at no cost to the community.

#### VII. New Business

- a. **Lot monitoring –** Forms filled out with towing taking place from 12 midnight until 6am Monday through Thursday. Excluding Friday through Sunday.
- b. **Excess visitors report** As requested, Harry Stevens provided the president with a report with an excess access visitors report. This report provided the frequency of users gaining access to the EOTL community via the gate system. The report was from December 2, 2018 through June

3, 2019. This will help us address issues such as speeding through the community. It is apparent that the drivers speeding through the community are not residents, since we are unable to locate the vehicles after we review the videos.

# **VIII. Open Forum**

- a) Follow up to include, the cost for painting no parking in the corners of the community, where we have double lines which indicate no parking. This will help address the lack of concern the visitors and homeowners show when parking in curves around the neighborhood.
- b) We also need to schedule our sidewalk repairs for the month of September 2019.
