As of 10/31/14 we have, in Banco Popular, \$79,953.77, in Checking, \$23,958.33 in savings, plus CD's of \$161,355.85 for total funds in Banco Popular of \$264,267.95. As of 10/31/14, in People Credit Union, we have \$38,870.76 in Savings and CD's of \$30,355.89 for total funds in PCU of \$69,226.65. We earned \$20.94 extra income, unexpected income of \$73.32 and \$0.00 in reimbursement income. We have accounts receivables over 7.9K which includes \$296.25.00 in legal fees, \$400.00 in unit repairs and violations in the amount of 2.4K. The total amount for possible collection is approximately 6.2K.

We have 6 properties (Lots' 19, 36, 39, 61, 80 and 95) in various stages of foreclosure. Several of these lots are not delinquent. The others represent approximately 5K of the delinquency amount.
